MARKET RULES AND INFORMATION:

SUMMER MARKET: Every Friday, 9:00 am - 1:00 pm April 24 to November 13

LOCATION: Downtown Enderby on Cliff Avenue (from the highway to Vernon St.) and Belvedere Street (from alleys behind the Pharmacy and Bottle Depot to the library)

VENDOR EQUIPMENT: Vendors are responsible for their own protection from the elements and for all materials and equipment required for their booths such as a tent and table.

ALL VENDORS: are required to use weights to secure their Canopy (20 lbs. per tent post works best). 4-liter jugs filled with water is acceptable. If you arrive without weights, we will supply one time. If it happens again, you will be required to go home and get your weights.

If you miss your unloading time slot or the 8 am vehicle cut off time, you will have to bring all your booth/products in by hand/dolly. If you are late 3 times you will lose your assigned stall.

Set up: 7 am – 8:00 am

Market hours: 9 am – 1 pm

Take down: 1 pm – 2:30 pm

All vehicles must be removed by 8:30 am.

VEHICLES: No vehicles to drive in until **1:15 pm** after closing time.

SETTING UP: All vendors must unload their tent and products and park their vehicles prior to setting up.

PARKING: Vendors are expected to park away from the market. Please disperse vendor vehicles in the two big parking lots Russell Ave. (City Parking behind Hungry Jacks) and Maud Street (across from Red Apple Store) to allow for customers to find convenient parking. Once you have parked your vehicle, you can set up your booth.

DO NOT PARK IN THE ALLEY BEHIND THE GUARDIAN PHARMACY AS THEY NEED TO SAVE THESE SPOTS FOR CUSTOMERS.

VENDORS: Must take down their entire booth, including the tent before they can go and bring their vehicle for loading up (DO NOT UNLOAD IN THE DRIVING LANES). Please be courteous to your fellow vendors.

CLEAN UP: Everyone is expected to leave their stall clean.

Garbage bins supplied by Enderby City or the market are for customer use only! Vendors are responsible to take their own garbage and recycling home.

ALL VENDORS: Must call the Market Manager no later than Wednesday night before the market day (earlier if possible) if they are unable to attend a market and wish to maintain their stall space in the future. Penalties will apply for non-compliance.

VENDORS: Who fail to give proper cancellation notice, with the exception of illness or emergencies will be given a notice for the first infraction, a vendor that fails to give proper notice a second time, will lose their

assigned stall space. Any vendor who abuses the Policy will not qualify for an assigned stall space for the following season.

PLASTIC BAGS: In order to reduce our carbon footprint vendors are encouraged to use paper bags or sell/give away reusable bags for customers. Please do not use plastic shopping bags at our market!

DOGS: Please leave your furry friends at home. Vendors are not allowed to keep their furry pet with them in their booth unless a certified animal.

Coupons: Each Vendor is responsible to have their coupons counted up and marked the amount before handing them in, also make sure they are for the current season, otherwise you will not be reimbursed. There is **NO change** to be given with the coupons.

UNACCEPTED VENDORS: Our market is religious and politically neutral. We are unable to accept organizations or vendors at the market who have religious or political mandates.

PLEASE FILL OUT THE ATTACHED APPLICATION. ALL APPLICATIONS WILL BE CONSIDERED BY OUR MARKET JURY. THE JURY RESERVES THE RIGHT TO LIMIT THE NUMBER OF VENDORS IN TOTAL WITHIN PRODUCT CATEGORIES. THE JURY WILL USE HIS/HER DISCRETION TO BALANCE THE TYPES OF PRODUCTS AND SERVICES AT THE MARKET. WE WILL INFORM YOU IF YOU ARE ACCEPTED.

FEES:

DAY VENDORS: are on a waitlist each market and are notified by email or phone call if a spot is available. They are given spots based on availability and will not necessarily be the same spot each time they attend.

Vendor fees are for one 10x10 spot. Every vendor must purchase an Annual Membership of \$10.00 to become a member of the Enderby Farmers Market. Our year runs from March-March.

SEASON VENDORS:

INCLUDE A PAYMENT WITH APPLICATION - \$350 (plus \$10 membership) must have completed 14 consecutive markets the previous year.

DAY VENDORS: \$25.00 per market plus \$10.00 membership. **Payment for day vendors is due before the market day. Payments made preferably by e-transfer but can also be made with cheque or cash for the following week. *There are no refunds on any fees paid.**

Applications must be received by **March 15** for the current season vendors.

DAY VENDORS: Must attend 14 outdoor markets consecutively as a Day Vendor, to be eligible to apply for a Seasonal Stall. As a Day Vendor you will not necessarily have the same spot each time you attend.

Once you have reached the maximum rental fee and have attended 14 markets in one season, **(and if you have been approved as a Season Vendor)** you may continue to attend the Enderby Farmers Market without paying additional fees for the remainder of the season if you attend the market until October 9th. It is the responsibility of the Day Vendor to keep all receipts and notify the Market Manger once the cap has been reached. Refunds are not given for overpayment.

PREPARED FOOD SELLERS:

1) VENDORS: of high-risk foods must provide copies of approval from Interior Health each season and a complete product list along with their application before selling at the market. Higher risk foods must be prepared in an approved commercial food premise; address of premise must be included on the application.

2) LOW RISK FOODS: also require a FoodSafe or MarketSafe Certificate with their application.

All value-added and processed food products require clear and legible labels, including the name and contact information of the producer and the list of ingredients in order of predominance.

All open prepared food must be kept covered at all times and be served using appropriate, clean tools (e.g., tongs, cloth napkins).

All food products must be made in accordance with Interior Health Regulations and Rules.

A copy of your current Food Safe certification must be present with your Vendor application and be available on site at all times, to be shown on demand. We prefer that a laminated version of your Food Safe Certificate be on display in your stall.

3) COSMETIC PRODUCTS: vendors that produce cosmetics, soaps, essential oils, and salves. All ingredients should be labeled on all cosmetic products. including the name and contact information of the producer For all vendors selling cosmetics, a [Cosmetic Notification Form](#) is required by Health Canada (Cosmetic includes any substance or mixture of substances, manufactured, sold or represented for use in cleansing, improving or altering the complexion, skin, hair or teeth and includes deodorants and perfumes). A copy of this notification must be provided to the market manager at the time of application. There is no fee associated with the cosmetic notification process.

4) ALCOHOL VENDOR: must have Authorization from LCLB

5) CRAFT VENDORS: All crafts must be produced from original materials by the seller. No resale items are permitted.

All craft products must be of original, unique work or design, and be of acceptable quality standards.

6) Non-profit groups may attend the market three days during the season.
