The Enderby Winter Market will be on Cliff Ave 9 am to 12 pm Friday's October 25<sup>th</sup>, November 1, 8, 15<sup>th</sup>

The Winter Market will move into Splatsin Center, 5767 Old Vernon Rd, Enderby. 9am.- 1pm. Nov. 29, Last Market is Dec 13

THERE will be TWO CHRISTMAS MARKET this year the first one is FRIDAY NOVEMBER 22<sup>nd</sup> the second one is DECEMBER 6<sup>th</sup> at the Splatsin Center, 5767 Old Vernon Rd, Enderby. 10am – 3pm.

THE WINTER MARKET features locally grown produce, home baking, handmade arts and crafts and quality products to complement the market selection. No resale items allowed!

Prepared Food Sellers: All food products must be made in accordance with Interior Health Regulations and Rules.

Vendors selling prepared food items are asked to attach a copy of their Food Safe Certificate and must display a copy of the Certificate on their table.

This is a NO PLASTIC BAG market! Vendors are encouraged to use paper bags, or sell/give away reusable bags for customers. Please do not use plastic shopping bags at our market!

Set up time for Cliff Ave is 8:00 am, Closing time is 12 pm. Vendor Fee \$25.00 per day.

### **BELOW ARE REGULATIONS FOR SPLATSIN CENTER**

Set up time for Splatsin is 8:00 am to 8.45 am. Closing time 1:00 pm, no packing up early!

Set up time for the Christmas market is 8.00 am to 9.45 am. Closing time is 3.00 pm, no packing up early!

Everyone is expected to leave their stall clean at packing up time. Garbage bins supplied by Splatsin Centre or the market are for customer use only! Vendors are responsible to take their own garbage and recycling home.

**PARKING:** Vendors have to park their vehicles after unloading in the designated vendor parking area.
